The following rates are for the Winter Monthly Stay 2022 - 2023

All sites are charged at a daily rate of \$25.00 when a minimum of 30 days is booked.

These prices include power, water, sewer and premium WIFI.

The first month is required with your booking and subsequent payments will be made on the first of every month. A credit card must remain on file for the payment.

We have enclosed the winter monthly stay information sheet. The rules apply to all campers and visitors staying in or visiting the campground. As well, we've enclosed a Winter Stay Request Form that is due back to us with the deposit.

All campers must be able to tow their RV out of the campground with 2 hours' notice. All campers must sign and return the Winter Camping Waiver (last 2 pages of this document) when they return their request form to us.

Please be advised we will not be accepting mail for our guests through Pathfinder Camp Resorts – Parksville's PO box as this poses a liability for the campground.

Monthly Program is from October 14th, 2022 to April 11th, 2023

1. Your site fee includes your RV unit and 2 vehicles. 1 vehicle can be parked at your site. 2nd vehicles are to be parked in the designated parking. No parking on grass. All vehicles/RV units/ cargo trailers must display valid insurance. No excessively noisy vehicles are permitted. Cargo trailers/dolly wheels must be parked in a designated storage site. Fees apply.
2. Site fees are based on 2 adults. Fees for additional occupants.
3. Maximum 2 pets per site. Dogs & cats must be leashed at all times and never left unattended. Dog waste disposal stations are located in the park; owners are responsible for waste cleanup.
4. No site alterations are permitted. Only outdoor furniture is to be kept on the site. Add-a-rooms are fine as are small pet enclosure no larger than 5' x5' and 3' high. Enclosures are restricted to the gravel pads. The following are not allowed on sites: decks, freezers, fridges, tarps, generators, fencing of any kind. All carpeting must be put on the gravel. Soft sided sheds maximum 8X8 and screen tents maximum 10X10 are allowed.
5. Guests are responsible for their visitors. Please arrange to meet them at the gate and let them in. Guests are responsible for the behavior of their visitors while here, Visitors are to park in designated additional parking inside the campground.
6. Proof of Personal Insurance for your RV which also gives provides liability coverage, issued through your RV insurance provider will be required and due with final payment. A minimum of \$3M liability coverage is required.
7. No excessive noise at any time. Campfires are permitted until 11pm
8. Sites are for the exclusive use of the registered campers. Sites are not to be sublet.
9. The speed limit within the park is a maximum of 10 Km per hour. Please follow all signage in the park.
